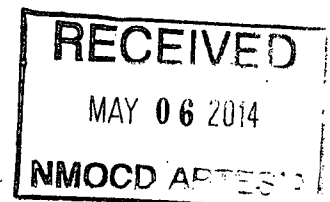

Enterprise will be required to shut in this pipeline while it is be re-routed out of the habitat and is estimated to take one year. This well was shut-in 3/17/14.
