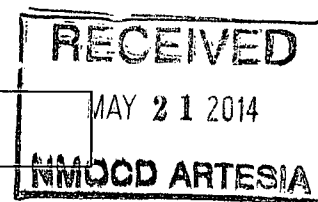

4/12/14 - Spudded well with rathole service at 8:00 am. Set 60' of 30" conductor and cemented with 6 sacks redi-mix to the surface.
4/15/14 - Resumed drilling with rotary tools at 11:30 pm.
4/17/14 - TD 14-3/4" hole to 1,011'. Set 9-5/8" 36# J-55 LT&C casing at 967'. Cemented with 360 sacks Class "C" + 4% D020 + 5#/sx D042 + 5% D044 + 0.2% D046 + 0.3% D112 + 0.125#/sx D130 + 94#/sx D903 (yld 2.21, wt 12.8). Tailed in with 250 sacks Class "C" cement + 5#/sx D042 + 0.2% D046 + 0.125#/sx D130 (yld 1.35, wt 14.8). No returns. WOC. Notified NMOCD of casing and cementing operations and failure to circulate cement.
4/18-19/14 - TIH with 1" and tagged at 131'. Cemented with 474 sacks Class "C" (yld 1.33, wt 14.8). Circulated 64 sacks to the surface. WOC. Tested casing to 1200 psi for 30 mins, ok
4/20/14 - WOC 67 hours 15 mins. Reduced hole to 8-3/4" and resumed drilling.
