 1/14/14 - Ran a CBL/GR/CC log from 8,415 ft to surface. Held 1200 psi on casing while logging.  
 2/20-21/14 - Perforated Bone Spring 8,507 ft - 12,687 ft (468 holes). Acidized with 67,500 gals 7.5 percent HCL acid, frac with a total of 4,768,156 lbs 20/40 and 16/30 White sand.  
 3/8/14 - Circulated hole clean down to 12,690 ft.  
 3/9/14 - AS-1 packer at 8,246 ft. 2-7/8 inch 6.40 lb L-80 tubing at 8,252 ft.
