After cmtg the 8-5/8" intermediate csg, we were unable to set slips due to cmt setting up before we could nipple down. Onsite drlg consultant (Clayton Brooker) contacted Kevin (BLM rep in Roswell) & Kevin verbally approved our plan to remedy. Kevin requested a sundry sent as soon as possible explaining procedure to remedy:

*Cut off the 13-3/8" csg head & welded cap on the 13-3/8" csg around the 8-5/8" csg. We then installed a 2" ball valve on the 13-3/8" csg & welded on 8-5/8" x 11" 3M csg head prior to proceeding with operations.
