- Clean location, test anchors, prep well for workover rig.
- MIRU. ND WH. NU BOP & 2-7/8" handling tools. Hang rods & tbg.
- MIRU WL truck. RU lubricator & RIH w/GRJB to 8250'. Note: CIBP @ 8266'.
- RIH w/perf gun & perf 4 spf 8230-8240 (40 holes) & 2 spf from 8180-8230' (50 holes). Note any gas on fluid flow. RD WL
- PU pkr & test in hole to 8050'. Set pkr. Test backside to 500#.
- MIRU chemical/pump trucks for RESTORE treatment and test lines.
- Pump PEP3 and PEP28 mixed w/xylene. Allow treatment to soak for 24 hrs. REMO pump truck & chemical container. SDON.
- MIRU acid/pump trucks. Pump PEP39 w/1500 gals 15% NEFE HCL. Displace w/PEP39 mixed w/2% KCL. Allow treatment to soak 2-4 hrs.
- Open well up and flow back load. Record volumes/rates.
- Unset pkr & TOH. RIH w/SN & production string. Set EOT @ +/-8100'.
