This well was plugged and abandoned and the dry hole marker was set 3/2/2011. After inspections from the BLM, more issues were reported to Devon, which have all been taken care of.



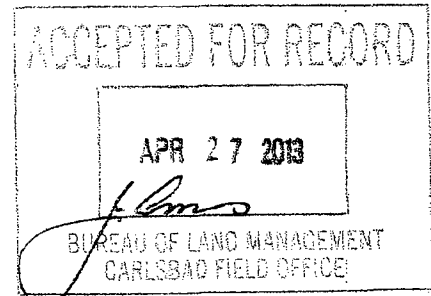
