Describe Cause of Problem and Remedial Action Taken.* **A valve malfunctioned causing 3 barrels of oil and 12 barrels of produced water to be released. The facility was shut-in, the valve repaired and put back into service. A vacuum truck was immediately called to the location and 3 barrels of oil and 5 barrels of produced water was recovered. Talon/LPE was contracted to perform an initial site assessment and soil sampling.**

Describe Area Affected and Cleanup Action Taken.*
The affected area is approximately 15' x 25'. This release was isolated on location only.
