Spud well on 7/21/14. Drilled 12-1/4" hole to 485'. Landed 8-5/8" 24# J-55 csg @ 482'. Cmted w/350 sx (469 cf) "C" cmt w/2% Cacl2, & 1/8#/sx cello-flake. Circ 146 sx cmt to surface. On 7/23/14, PT 8-5/8" csg to 1500 psi for 30 min – OK.

Drilled 7-7/8" hole to TD4750' on 7/28/14. Ran open hole logs. Landed 5-1/2" 17# J-55 csg @ 4747'. Cmted lead w/200 sx (381 cf) 35/65 poz C cmt w/5% salt, 6% gel, 5# LCM, 0.25# CF, & 0.2% R-3. Tailed w/905 sx (1203 cf) "C" cmt w/0.6% R-3 & 0.25# CF. Circ 145 sx cmt to pit. Released drilling rig on 7/30/14. Plan to pressure test the 5-1/2" csg before completion operations.
