BOPCO L.P. respectfully requests to cut off 16" A section wellhead and install a 13-3/8" X 13-5/8" , 5000 psi working pressure SOW on to the 13-3/8", 68 ppf, HCL-80, UFJ casing. The reason for the cut off is due to not being able to set slips after cementing the 13-3/8" casing to surface, during nipple down cement set up inside wellhead. A metal plate will be welded across the open annulus between the 16" and 13-3/8" casing.
