 2/6/2014 - RIH w/ 8-10K retrievable bridge plug @ 4880'. Test to 2000 psi. Load hole with fresh water and install adaptor flange, 5K 7-1/16" frac valve and goahead with 4 frac inlets. RU WSU unit and spot 1000 gal of 7.5% acid.  
 2/12/2014 - Frac Yeso 4 4519 - 4829' (20) using 3000 gals 7.5% HCL, 12,995 bbls of slickwater carrying 193,113# of sand.  
 2/14/2014 - Killed well with 30 lbs of brine. Clean out 30' sand with foam unit. RIH w/ tubing and pull retrievable bridge plug @ 4880'.  
 2/17/2014 - RIH w/ seating nipple @ 5952', 46 jts 2-7/8" tubing, TA @ 4470', 2 jts 2-7/8" tubing w/ 2' sub, 137 jts 2-7/8". RIH w/ 20" Quin pump w/ sandscreen, 6 - 1-1/2" Kbars, 230 7/8" rods, 1 - 2' and 1 - 6' sub, 26' polished rod. Load hole with 20 bbls of water. Hang well and begin pumping.


