LOCATION RECLAMATION PLAN

WHL #27 - Location Reclamation Plan - see attached location plat/picture.

The caliche pad and entrance road will be picked up and stockpiled at the WHL central battery for use in the Unit area. Soil underneath the pad will be contoured, ripped and seeded with BLM #3 mixture. The entrance road will be barricaded with a berm along the main road to prevent vehicular traffic. Location will be monitored to evaluate re-vegetation. If circumstances change while in the restoration process the BLM will be contacted to approve variation from the plan.
