The road will serve as access to the well location and facilities and be 30' in width. The existing road access on the Southeast corner of the location will be reclaimed. A fence will be installed around the reclaimed access road blocking access to and from the location around the reclaimed area shown on attached plat. The new road access is necessary to accommodate new equipment resulting from Quad O standards for venting gas.
