7/14-19/14 - Set composite plug at 7,248'. Perforated Yeso 2,760' - 7,228' (590 holes). Acidized with 67,243 gallons 20% HCL acid, frac with a total of 5,993,978# of 100 Mesh and 40/70 Brady sand. 2-7/8" 6.40# J-55 tubing at 2,162'.
