This well was plugged in April of 2009. Primero Operating, Inc. recieved a Written Order #04-003-10W on 1/12/10 citing 5 Environmental Problems.

Shortly after the written Order, Primero Operating did the following per Written Order:

The current surface owner was contacted and was in the loop on all actions: We removed the gas Meter run and cut off the sales line below ground level and backfilled the excavation as necessary

The current rancher at the time desired to keep a flat spot on the location order to put a feeder for his livestock. A written statement was obtained from him clearing the final abandonment and some work was done to restore the original grade. Unfortunately the written notice was missplaced. The ranch was sold between the time the work was done and present.

See above concerning the hill cut reclamation

The disteurbed/reclaimed area of the well has been re-seeded with the desired Plant community seed mixture.

A Final Anandonment Notice has be filed simultaneously with this Sundry Notice.
