Drilled 7-7/8" hole to MDTD3625' on 3/26/14 & set 5-1/2" 17# J-55 production csg @ MD3609'. Cmted lead w/310 sx (598 cf) 35/65 POZ "C" cmt w/5% salt, 6% gel, 2% R-3, & 1/8# cello flake & tailed w/375 sx (495 cf) cl "C" cmt w/0.5% PF-13, 2% PF-167, 0.2% PF-65, & 0.125# PF-29. Circ 163 sx cmt to surface. Released drilling rig on 3/27/14. Plan to pressure test 5-1/2" csg during completion operations.
