

El Paso Natural Gas Company, L.L.C. (EPNG) proposes to drill the WI Federal #25 well in September 2014 after receipt of an approved BLM permit and a FERC Notice to Proceed, once a rig is available.

On March 21, 2014, El Paso Natural Gas Company, L.L.C., as Unit Operator of the Washington Ranch Gas Storage Unit, delivered an original and three copies of BLM 3160-3 and attachments for EPNG's proposed WI Federal #25 to the Bureau of Land Management's Carlsbad New Mexico Office.

This notification is a requirement of Item #6 of the "Application of El Paso Natural Gas Company for Underground Gas Storage, Eddy County, New Mexico (October 17, 1979), Case No. 6703, Order No. R-6175.

This well will utilize a closed loop system during all drilling operations.


