Cmt 3 plugs w/ 174 sks of Class C w/4% CaCl₂. Mixed @ 14.8#/g w/1.34 yd. At 6:00 P.M. 02/16/14, tested BOPE & csg to 1250# for 30 mins, held OK. Drilled out with 12 1/4" bit.
