

Describe Cause of Problem and Remedial Action Taken.*

A quarter inch nipple was broken off the wellhead by a cow rubbing up against the wellhead. A vacuum truck was dispatched to recover any standing fluid and the location was scraped.

Describe Area Affected and Cleanup Action Taken.*

The impacted area was approximately 100'x400', the area was scraped and treated with Microblaze. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
