9/23/14 - Set 7 inch CIBP at 7,990 ft. Pumped 297 bbls of 3 percent KCL. Pressured up to 2900 psi. Well went on vacuum. Pumped 20 bbls, well still on a vacuum. Tagged CIBP at 7,990 ft, pulled up and set another CIBP at 7,980 ft. Pumped 280 bbls 3 percent KCL.
9/24/14 - Pumped 40 sacks of Class H cement. Displaced with 45 bbls. POOH to 6,481 ft. Reversed out 40 bbls. WOC for 4 hours. Tagged TOC at 7,712 ft and pulled up to 7,554 ft. Tested casing to 3000 psi with a chart for 30 mins.
9/25-27/14 - Perforated Bone Spring 7,198 ft to 7,396 ft (81 holes). Set AS-1 packer at 6,945 ft. Tested tp 1500 psi, held good. Swabbed tubing from surface to 6,945 ft.
9/28/14 - Pumped 3000 gallons 7.5 percent HCL acid.
