Mack Energy proposes to lay (4) 10" lay flat surface lines from our Round Tank Pit to our Calgary Federal #6 location. Total Distance of these lines will be 7800' in length. Lines will carry 25,000 bbls of produced water from our frac pit to location for the purpose of fracing the Calgary Federal #6. Anticipated frac date is 12/17/2014. We ask for a 30 day window to allow for schedule conflicts. These lines will be laid on the surface along side of the existing road, within 2' of the roads edge.
