


Describe Cause of Problem and Remedial Action Taken.*
A sight glass failed on the two phase separator, the sight glass was replaced.

Describe Area Affected and Cleanup Action Taken.*
The majority of the spill was contained in 0-Perm containment around the process equipment. Due to the pressure of the release approximately 7,225 sq. ft. of caliche pad area was impacted by the release. A vacuum truck recovered 312 bbls of oil and 78 bbls of water from the containment, and picked up 3 bbls of oil off the ground. The equipment was power washed. It was estimated that a total of 5 bbls oil and 4 bbls of water saturated into the soil. The spill areas will be cleaned up in accordance to the NMOCD and BLM remediation guidelines.
