Devon Energy Production Company, L.P. believes that, with the results from the pressure test, we have good isolation and would like to proceed with our planned stimulation on 1/23/15. Below describes how we will monitor the annulus during the frac job.

During the frac job, we will tie onto 9-5/8 x 5-1/2 annulus and install pressure transducer and spring loaded pop-off. The pressure transducer will be hooked up to the frac van where it can be monitored at all times during the frac job.

In the event that the pressure exceeds 1000 psi, operations will be shut down and the engineer will be notified.

Contact BLM if pressure is exceeded.
