Pump Plug 3, 100 sx Class C @ 750', Fill casing. - Surface to 750'

11/25/14: RD Pulling unit. Cut off casing 3' below ground and welded on plate.

The pumping unit, tubing and rods have been removed from location. The location will be cleaned to BLM standards.
