Mewbourne is currently permitted to run a 4 1/2" liner with packer/port completion system. The following change is requested:

Run 4 1/2" cemented liner with packer type liner hanger from 8333'MD (200' inside 7" csg) to 13200'MD. Cement with 450 sks of Halliburton VersaCem w/0.2% LAP-1, 0.2% Halad(R)344, 0.25lb D-air 5000, 0.4% HR601. Yield: 1.295 Cuft/sk @ 14.2 lb/gal. Mix fluid 6.11 gal/sk.

Cement volume calculated with 25% excess.

The well is currently at total depth of 13200'MD (8356' TVD). 7" 26# P110 csg is set @ 8538' MD (8238' TVD).
