Rig up wireline & run temp log & found cmt @ 137'. RIH w/ 1" & tag cmt @ 140' pump 106sx (25bbl) PPC w/ additives 14.8ppg 1.4 yield, circ 21sx (5bbl) to surface. 10/16/14 Install WH, test to 1000#, test passed, RU BOP, test @ 250# low 5000# high. Test csg to 2150# for 30 min, test passed. RIH tag cmt @ 317' drill out to 390', perform FIT test to EMW=14.8ppg, 100psi, tested good.

10/17/14 Drill to 10-5/8" hole to 2937' 10/18/14. RIH & set 8-5/8" 32# J-55 BTC csg @ 2937'. Pump 20BFW spacer then cmt w/ 700sx (211bbl) PPC w/ additives 12.9ppg 1.87 yield followed by 230sx (54bbl) PPC w/ additives 14.8ppg 1.33 yield, circ 352sx (106bbl) to surface. Install pack off mandrel, test to 5000#, tested good. 10/20/14 RIH & tag cmt @ 2850', test csg to 2750# for 30 min,
