LRE has recompleted this Yeso oil well to the San Andres as follows: On 4/1/15, MIRUSU. TOH w/rods, pump, & tbg. Set 5-1/2" CIBP @ 3150' & PT 5-1/2" csg & CIBP to 4000 psi-OK. (Existing Yeso perfs are @ 3210'-3994'). Perfed lower San Andres @ 2750'-3052' w/1-0.40" spf. Total 30 holes. On 4/7/15, treated w/1500 gal 15% HCL acid & fraced lower San Andres w/30,381# 100 mesh & 253,091# 40/70 Arizona sand in slick water.

Set 5-1/2" CBP @ 2700'. PT csg' & CBP to 4000 psi-OK. Perfed middle San Andres @ 2330'-2650' w/1-0.40" spf. Total 33 holes. Treated perfs w/1500 gal 15% HCL acid & fraced w/31,000# 100 mesh & 281,693# 40/70 Arizona sand in slick water.

Set 5-1/2" CBP @ 2290'. PT CBP & 5-1/2" csg to 4000 psi-OK. Perfed upper San Andres @ 1728'-2222' w/1-0.40" spf. Total 30 holes. Treated perfs w/1500 gal 15% HCL acid & fraced w/29,299# 100 mesh & 178,396# 40/70 Arizona sand in slick water.

On 4/8/15, MIRUSU. Drilled CBPs @ 2290', 2700', & CO to CIBP @ 3150'. On 4/9/15, landed 2-7/8" 6.5# J-55 tbg @ 2943'. Ran pump & rods. Released completion rig on 4/9/15. Completed the well as a single San Andres oil well. Following a test on the San Andres alone, the CIBP @ 3150' will be removed and the well DHC as per State order ART-4609-V.
