Apache request to change the weight of the 13-3/8" surface casing from 54.5# J55 STC to 13-3/8" 48# H40 STC, the safety factors for burst are 4.32, collapse is 4.302 and yield is 16.77.

Apache also request to change hole size after drill out of intermediate from 8-3/4" hole thru the curve and 7-7/8" in the lateral to 8-1/2" hole from under intermediate to TD. Cement volumes will remain the same as approved on APD.
