This well was fractured in the Grayburg/San Andres formations on 1/14/10 and 1/15/10. On 1/16/10 the Grayburg/San Andres production from the Puckett North #1 Well, API #30-015-34746, located in Section 12, T17S-R31E, 1880' FSL and 560' FWL, Unit L, Eddy County and Puckett North #3 Well, API #30-015-36633, located in Section 12, T17S - R31E, 810' FSL and 2260' FWL, Unit N, Eddy County, dropped off dramatically, indicating we had communicated with, or "hit", the wellbores during the frac treatment. Over the next several days, the production from the "hit" wells returned to normal, indicating the reservoirs had equalized.
