On 10/3/14, pressure tested 8-5/8" csg to 1500 psi for 30 min-OK. Drilled 7-7/8" hole to TD4537' on 10/10/14. Ran open hole logs. On 10/11/14, set 5-1/2" 17# J-55 production csg @ 4533'. Cmted w/lead 350 sx (669 cf) 35:65 poz "C" cmt w/5% PF-44, 6% PF-20, 0.2% PF-13, 0.125# PF-29, 0.4# PF-45, & 3# PF-42. Tailed w/510 sx (683 cf) cl "C" cmt w/0.3% PF-13, 0.2% PF-65, 0.3% PF-606, 0.125# PF-29; & 0.4# PF-45. Circ-203 sx cmt to pit. Released drilling rig on 10/11/14. Plan to pressure test 5-1/2" csg during completion operations.
