Circ 121 sks of cement to pit. WOC. At 4:30 A.M. 01/25/15, tested csg & BOPE to 1250# for 30 minutes, held OK. Drilled out with 12 1/4" bit.

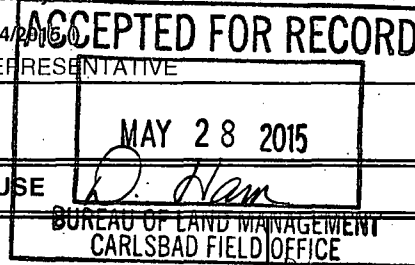
