LRE has recompleted this Yeso oil well to the San Andres as follows: On 6/10/15, MIRUSU. TOH w/rods, pump, & tbq. Set 5-1/2" CBP @ 3250' & PT 5-1/2" csg & CBP to 4000 psi-OK. (Existing Yeso perms are @ 3310'-4580'). Perfed lower San Andres @ 2766'-3110' w/35-0.42" holes. On 6/16/15, treated new perms w/1500 gal 15% HCL acid & fraced lower San Andres w/29,386# 100 mesh & 304,471# 40/70 Ottawa sand in slick water.

Set 5-1/2" CBP @ 2700'. PT CBP & 5-1/2" csg to 4000 psi-OK. Perfed middle San Andres @ 2238'-2640' w/40-0.42" holes. Treated perms w/1500 gal 15% HCL acid & fraced w/30,558# 100 mesh & 344,409# 40/70 Ottawa sand in slick water.

Set 5-1/2" CBP @ 2150'. PT CBP & 5-1/2" csg to 4000 psi-OK. Perfed upper San Andres @ 1758'-1992' w/35-0.42" holes. Treated perms w/1500 gal 15% HCL acid & fraced w/32,345# 100 mesh & 126,826# 40/70 Ottawa sand in slick water.

On 6/17/15, drilled CBPs @ 2150', 2700', & CO to CBP @ 3250'. On 6/17/15, landed 2-7/8" 6.5# J-55 tbq @ 3138'. Ran pump & rods. Released workover rig on 6/18/15. Completed the well as a single San Andres oil well. Following a test on the San Andres alone, the CBP @ 3250' will be removed and the well DHC as per State order ART-4609-Z.
