As a result of a One-Call placed before earth moving operations commenced on the proposed WI Federal #26 well site, a 440V cathodic line buried at a depth of six inches was located. Based on this finding, it was recommended that EPNG relocate the stored topsoil above the buried line in order to protect it during construction activities. The proposed new topsoil storage area appears on the attached plat.


