RIH & set 11-3/4" 47# J-55 BTC csg @ 324', pump 20BFW spacer w/ red dye, then cmt w/ 300sx (89bbl) PPC 300sx (89bbl) PPC w/ additives 14.2ppg 1.67 yield followed by 250sx PPC w/ additives 14.8ppg 1.34 yield, circ 53sx (16bbl) cmt to surface. Plug didn't bump, leave cement head on for 8hrs. 9/12/14, RU BOP, test @ 250# low 5000# high. RIH & tag cmt @ 229', wash & ream cement to 257', test csg to 2150# for 30min, good test. Drill new formation to 335', perform FIT test to EMW=10.0ppg, 55psi, good test.
