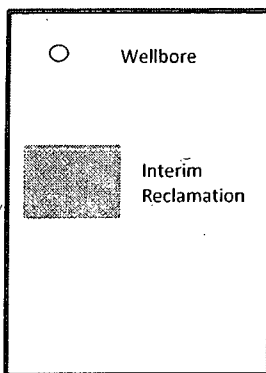
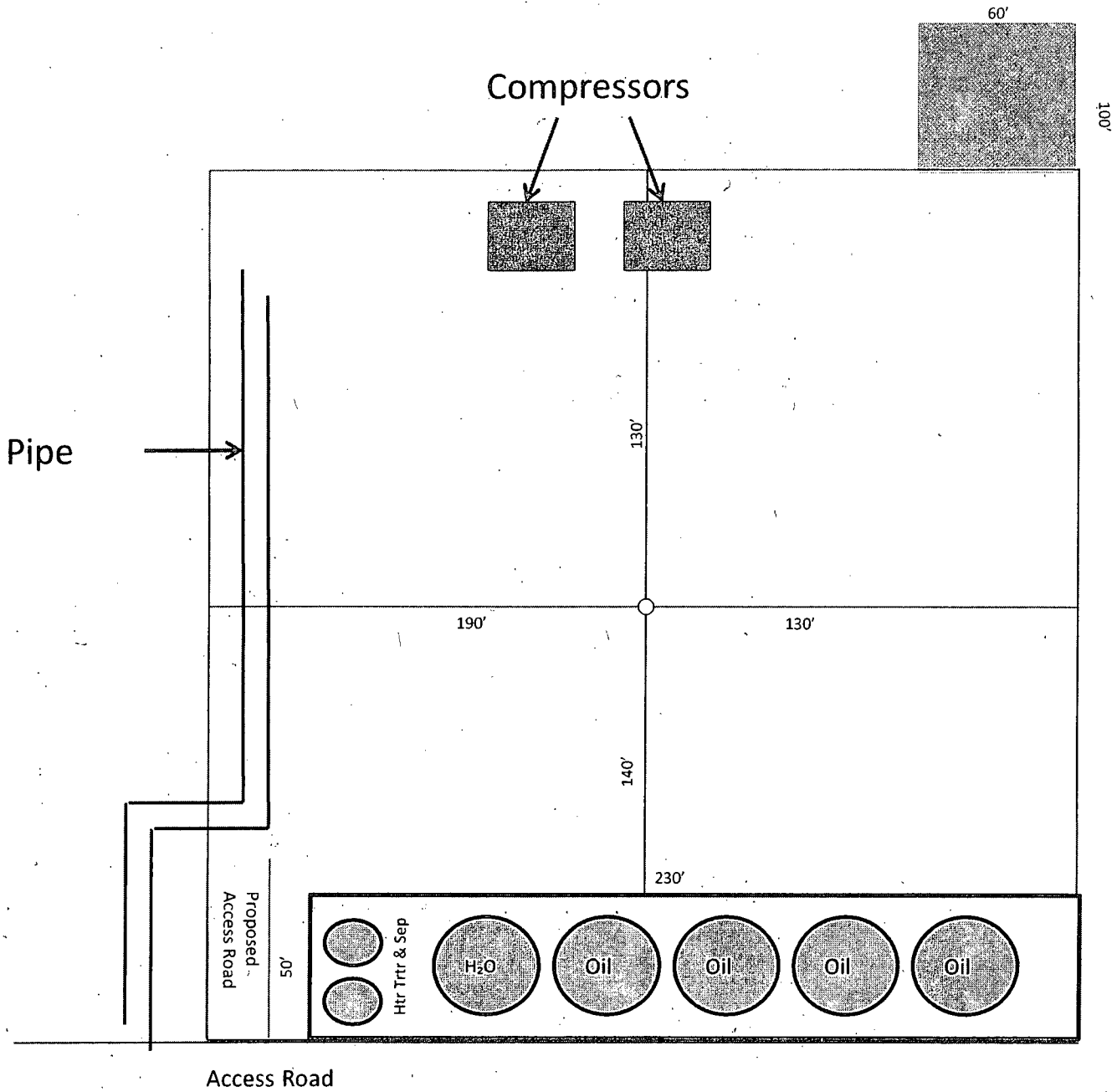


Exhibit D-1
