The well has a surface leak. Sounds like there is either a tubing or packer leak, that then caused the casing to pressure up and expose a shallow casing leak. Will test casing with plug and packer to isolate the leak. Here is the WO procedure.

- 1- MIRU Workover Rig, ND wellhead NU BOP
- 2-Release Packer and pull the well.
- 3- Test the casing.
- 4- Fix the casing leak.
- 5- Scan out and pressure test tubings. and replace tbg as needed.
- 6- RIH w/ packer and 2 3/8 tbg and set the packer.
- 7- Put well back in injection.
