DUE TO PRIVATE LAND OWNERS REQUEST TO AVOID THE ORIGINAL ROAD & GAS/SWD LINE ROUTE TO THE NORTH, HE IS REQUESTING RKI REROUTE THE ROAD AND GAS/SWD LINE TO THE SOUTH AND EAST, FOR THE PREVIOUSLY APPROVED EAST PECOS FEDERAL 22-3H & 4H (TWO WELLS ON SAME PAD) WELLS.

THE LAND OWNER (WORTH ROSS OF ROSS RANCH) HAS AGREED TO THIS NEW ROUTING.

THE NEW ROAD ROUTE WILL BE 746.6 FT. OR 0.51 ACRES. THE BURIED 6" STEEL GAS PIPELINE AND SURFACE INSTALLED 4" POLY SWD LINE, WHICH WILL FOLLOW THE PROPOSED ROAD AND THEN ACROSS COUNTRY FOR 796.5' TO THE EXISTING PIPELINE VALVES, WILL BE 1,723.7 FT. OR 1.19 ACRES. INDRA DAHAL (BLM) WAS ON-SITE FOR THIS STAKING OF REROUTE AS WELL AS THE LAND OWNER WORTH ROSS.
