Drilled 7-7/8" hole to TD4780' on 12/22/14. Ran open hole logs. On 12/23/14, set 5-1/2" 17# J-55 production csg @ 4729'. Cmted w/lead 300 sx (579 cf) 35:65 poz "C" cmt w/5% salt, 6% gel, 2% R-3, & 0.125# CF. Tailed w/640 sx (845 cf) cl "C" cmt w/0.5% PF-13, 2% PF-167, 0.2% PF-65, & 0.125# PF-29. Circ 232 sx cmt to pit. Released drilling rig on 12/24/14. Plan to pressure test 5-1/2" csg during completion operations.
