10-11-2005 - Moved in pulling unit. Bled well down. Rigged up pulling unit. Nipped down wellhead. POOH with 1 joint of 2-7/8" tubing. Nipped up BOP. Shut well in for night.

10-12-2005 - SICP 50 psi. Bled well down. Well began slugging some oil to surface with a gas bubble. Shut well in. Rigged up pump truck. Pumped 45 bbls water down casing. After 8 bbls were pumped, well went on vacuum. Caught pressure after 30 bbls had been pumped. After 45 bbls pumped, had 500 psi pump pressure at a rate of 3 BPM. Shut down and went on vacuum in 5 minutes. TIH with bit, scraper and tubing to 1417'. TOOH with tubing, scraper and bit. TIH with packer and tubing and set packer at 1375'. Loaded casing with 8 bbls water and tested to 600 psi. Lost 40 psi in 30 minutes. Had slight leak on BOP. TOOH with packer and tubing. TIH with a tubing set CIBP and set CIBP at 1375'.

Pulled 1 joint tubing. Circulated hole with fresh water and corrosion chemical. Shut in and tested to 500 psi. Load 20 psi in 30 minutes. Still had slight leak on BOP. TOOH with CIBP setting tool and tubing. Nipped down BOP. Installed a 2-7/8" X 4' tubing sub in wellhead and packed off. Pressure tested to 500 psi for 30 minutes. Lost 5 psi. Had slight leak on nipple in head. Bled off and tightened nipple. Rigged down and moved off pulling unit. MIT is scheduled for next week.

10-22-2005 - Rigged up pump truck. Loaded casing with water. Installed pressure recorder and pressure tested to 500 psi for 30 minutes, held OK. Please see attached chart for Mechanical Integrity Test ran on October 21, 2005. NOTE: Chris Beadle with OCD-Artesia witnessed Mechanical Integrity Test. TEMPORARILY ABANDONED.
