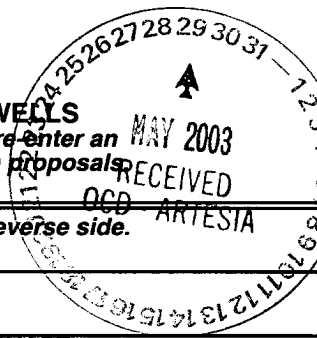

1. Notify BLM 24 hours before starting plugging operations.
2. Set 35 sx cement plug from 6500-6400'.
3. Set 35 sx cement plug from 4500-4400'.
4. Set 35 sx cement plug from 1500-1400'.
5. Set 35 sx cement plug from 323-223', 50' above and below 9 5/8 casing.
6. Set 10 sx surface plug.
7. Install dry hole marker.
