Tailed in with 200 sx Class "C" + 2% BWOC CaCl + 56.4% FW (yld 1.18, wt 15.6). Cement circulated to surface. Tested casing to 600 psi in 30 min. WOC 36 hrs 15 min. Reduced hole to 17-1/2" and resumed drilling.
