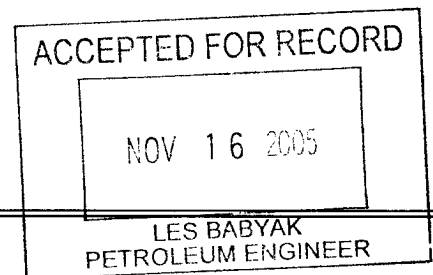

Tail with 600 sks Class "H" with additives. Mixed @ 15.1 #/g w/ 1.29 yd. Open DV tool with 924#. Circ thru DV tool at 7484'. Did not circ cmt off DV tool.
Cemented 2nd stage with 925 sks (35:65:6) BJ Lite H modified with additives. Mixed @ 12.5 /g w/1.95 yd. Tail with 200 sks Class "H" Neat. Mixed @ 15.6 #/g w/ 1.18 yd. Closed DV tool with 3300#. Slow rate lift pressure at 1700# at 2.5 BPM. At 12:30 pm 11/01/05, test 5 1/2" casing to 3300# for 30 minutes, held OK. Set 102k on slips.
