11/17/05 TOO H L/D 8" DC and held safety meeting. Rig up casing crew and run 44 joints of 40# P-110 and 91 joints of N-80 LTC. RU Schlumberger and circulate complete casing and annulus volumes. Pump 1,956 sx 35/65 poz C + additives and 200 sx of class C + adds circulated 340 sx. Rig down Schlumberger WOC 18 hours and jet pits nipple down BOP. Set slips under full tension and cut off. Nipple up BOP.

11/18/05 Nipple up BOP w/o tester. Test BOP, Choke, and Accumulator 2,500# high and 250# low for 30 minutes OK. P/U New BHA and 23 6" drill collars TIH and L/D 13 joints of DP. Drilling Cement and float collar.

11/19/05 Test casing for 30 minutes 1,500 psi high and 250 low. Drill out cement and float shoe.
