10/31/05 Resumed drilling at 8:30 PM.

11/1/05 Set 13-3/8" 48# H40 8rd ST&C casing at 330'. Cemented with 180 sx "H" + 10% A10 + 10# LCM + 1% CaCl + 1/4#/sx Celloflake (yld 1.52, wt 14.6). Tailed in with 40 sx "C" + 2% CaCl2 + 1/4#/sx Celloflake (yld 1.35, wt 14.8). Cement did not circulate. WOC 9-1/2 hrs. Ran 1" cement to surface with 100 sx Class "C" + 4% CaCl. Tested casing to 600 psi for 30 min. WOC 37 hrs 30 min. Reduced hole to 12-1/4" and resumed drilling.

11/4/05 Set 9-5/8" J-55 casing at 1628'. Cemented with 180 sx Class "H" + 10% A-10 + .25#/sx Celloflake + 1% CaCl2 + 10#/sx LCM-1 (yld 1.50, wt 14.6) and 433 sx 35:65:6 Poz "H" + .25#/sx Celloflake + 2% CaCl2 + 5#/sx LCM-1 (yld 1.98, wt 12.5). Tailed in with 200 sx Class "C" + 1% CaCl2 (yld 1.50, wt 14.6). Cement did not circulate. Ran 1" cement to surface with 300 sx Class "H". Tested casing to 1525 psi, ending psi 1475. WOC 42 hrs 30 min. Reduced hole and resumed drilling.


