If there is evidence of contamination, the soil will be tested by lab and if contamination is confirmed, further remediation will be conducted according to guidelines. The excavated material will be transported to the Oxy Bodacious Federal #1 and buried with the contents from the pit at that site. The excavated pit will be backfilled with clean soil and contoured with three feet of soil or like material capable of supporting native plant growth to prevent erosion and ponding of rainwater.
A one call and a 48 hour notice will be provided to the Oil Conservation Division.
