Additional Comments: Pit Closure Report – Pit contents were mixed with earthen material and allowed to stiffen. Encapsulation trench was constructed and lined with a 12 mil Synthetic liner. Pit contents were placed into the trench, then covered with a 20 mil synthetic liner with a 3 ft. overlap on all sides. The capping liner was then covered with 3 ft. of native soil and graded to prevent pooling. Closure began November 3, 2005 and was completed November 9, 2005.
