11/28/05 - 11/29/05 Drill cement from 4015' to 4435'. POOH, RIH w 8 3/4" bit, motor and BHA. Orient tool face.

11/30/05 - 12/04/05 Drill and build curve for horizontal well. Drill to 5199' MD, curve built, POOH. TIH w/7 7/8" bit, motor and BHA. Drill horizontal hole.

12/5/05 - 12/15/05 Drill 7 7/8" horizontal hole from 5199' to 8725' MD. TD well at 8725' MD. Circulate hole POOH to run 5 1/2" casing.

12/16/05 Rig up and run 5 1/2" casing. Run 5 1/2" float shoe BTC, 1 jt 5 1/2" 17#/ft P110 BTC casing, 5 1/2" float collar, 98 jts 4186.5' 17#/ft P110 BTC, 1 XO BTC to LT&C, 101 jts 4494.2' 5 1/2" 17#/ft N80 LT&C. Set casing at 8725'. Rig up cementers, cement casing w/800 sx 50/50 poz CL C+5%D44 .25 PPS D20+.25 PPS D29+2% D46, mix at 11.9 PPG, Yield 2.46, followed by 300 sx C1 C+200% D151+2% D13+.5% D112+1.5% D153+.15 GPS D604AM+.05 GPS D47, mixed at 14.5


