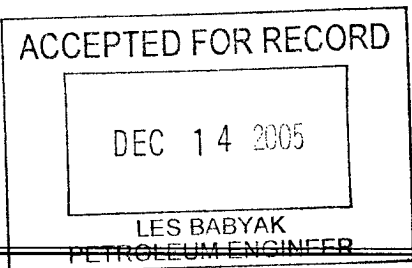

Tail with 500 sks Class "H" with additives. Mixed @ 15.1 #/g w/ 1.29 yd. Open DV tool with 650#. Circ thru DV tool at 8046'. Did not circ cement off DV tool. Cemented 2nd stage with 1200 sks (35:65:6) BJ Lite"H" modified with additives. Mixed @ 12.5 /g w/1.94 yd. Tail with 200 sks Class "H" neat. Mixed @ 15.6 #/g w/ 1.18 yd. Closed DV tool with 3400#. Slow rate lift pressure at 1570# at 3 BPM. At 9:00 pm 11/25/05, tested 5 1/2" casing to 3400# for 30 minutes, held OK. Set 155k on slips.
