12/14/05 Resumed drilling at 8:45 AM. Set 13-3/8" casing at 506'. Cemented with 220 sx Halliburton Lite Premium + "C" + 2% CaCl₂ and .25#/sx Flocele (yld 1.98, wt 12.5). Tailed in with 200 sx Premium "C" + 2% CaCl₂ (yld 1.35, wt 14.8). Cement circulated to surface. Tested casing to 1000 psi for 30 min. WOC 23 hrs 30 min. Reduced hole to 11" and resumed drilling.

12/18/05 Set 8-5/8" 24#, 32# J-55 ST&C casing at 3200'. Cemented with 800 sx Premium Lite + 2% CaCl₂ + .25# Flocele (yld 1.98, wt 12.5). Tailed in with 200 sx Premium Plus + 2% CaCl (yld 1.35, wt 14.8). Cement circulated to surface. Tested casing to 1500 psi for 30 min. WOC 39 hrs. Reduced hole to 7-7/8" and resumed drilling.
