Revised Directions: from the intersection of 62/180 (Greene Street) and Highway 285 (Canal Street) in Carlsbad, New Mexico, proceed south on Highway 62/180 towards El Paso, Texas, for a distance of approximately 77.1 miles to Texas Farm Road 1576. Turn north (right) on Farm Road 1576 and continue on 1576 for a distance of approximately 31.5 miles. The new road will start at the edge of the pavement going west-northwest to the top of the hill and continue on top for approximately 1.2 miles to where the new road will start going north. Continue north for approximately 1.4 miles to existing two track that has been upgraded. Turn east on upgraded two-track for approximately 1/2 mile to the southwest edge of the location.
