The NSLU #191, #194, and #187 are new drill wellbores that are part of the three pilot waterflood areas being developed on the North Square Lake Unit.

The first pilot area has recently been completed which included new drills NSLU #197, #198 and #199. Work on the second pilot area which includes new drill wellbores #191 and #194 is anticipated to start this spring, which will include completing wells #191 and #194.

The third pilot area is anticipated to start this fall and will include the completion of the #187.
